

# Meristem TruTrack™ C

## Drift Reducing Adjuvant and Deposition Aid for Ground and Aerial Applications

### GENERAL INFORMATION

Meristem TruTrack C is a specially formulated deposition aid with drift reducing properties that reduces the number of spray droplet fines less than 150 micro and increases the VMD (Volume Median Diameter) of spray droplets. Meristem TruTrack C generates a more uniform droplet size spectrum resulting in more enhanced on-target deposition and coverage of spray. Meristem TruTrack C can be used with most herbicides, fungicides and insecticides that are labeled for use in agriculture or forestry. Meristem TruTrack C is specially formulated for mixing with liquid AMS and Meristem AMS Surfactant Concentrate.

### DIRECTIONS FOR USE

Use Meristem TruTrack C at a rate of 2 – 6 fl. oz/Ac or 0.125–0.375% v/v. Other adjuvants may be added for deposition, retention and canopy penetration. Always read and follow the specific pesticide label directions, adjuvant suggestions, rates and mixing instructions.

When mixing with water conditioner and surfactant, always add water conditioning product first followed by surfactant, such as Meristem AMS Surfactant Concentrate and then add Meristem TruTrack C. Proper nozzle selection and operation (pressure and spray angle) along with Meristem TruTrack C combined with good operator evaluation and decision making on wind direction, temperature inversions, application speed and susceptible crops in the area are necessary for maximum drift reduction potential. Always use good operating procedures to minimize drift potential. Actual use rate may be increased or decreased with in the desired rate range to achieve optimum results. Always read and follow label directions.

### STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Do not contaminate water by runoff from equipment wash water or spray material.

**STORAGE:** Store in a dry place. Store in original container only with lid tight. Do not store near heat or open flame. Do not store with food, feed or other material to be consumed by humans or animals. Do not freeze.

**ADJUVANT DISPOSAL:** Improper disposal of product or spray mixtures or rinsate is violation of Federal Law.

**CONTAINER DISPOSAL:** Do not re-use empty container. Triple rinse container and pour rinsate into the spray tank. Recycle or dispose of containers according to local, state and Federal Laws.

### PRECAUTIONARY STATEMENTS

Avoid contact with eyes, skin or clothing. Avoid breathing vapors or spray mists. Use only with adequate ventilation. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, or smoking tobacco. Remove and wash contaminated clothing before reuse.

**Personal Protective Equipment:** Wear chemical resistant gloves, eye protection, long sleeved shirt, long pants, and shoes when mixing or applying Meristem TruTrack C.

### FIRST AID
