GENERAL INFORMATION

AQUADRAFT DICAMBA ALL-IN-ONE is a volatility and drift reduction adjuvant which is designed for use in dicamba tolerant cropping systems. The product should be used along with nozzle and pressure combination sufficient to generate an Ultra-Course droplet spectrum and suitable spray pattern.

AQUADRAFT DICAMBA ALL-IN-ONE uses a specially balanced buffering and volatility control system to provide a tank pH of at least 5.0 when tank mixed with glyphosate and dicamba herbicides.

AQUADRAFT DICAMBA ALL-IN-ONE provides ammonium free water conditioning and wetting which meets the label requirements for mixing with approved dicamba products to be applied on dicamba tolerant crops.

DIRECTIONS FOR USE

Prior to use, read all the directions on this label and on the label of all pesticides, fertilizers, and any other tank mix additives. Do not use unless a nonionic surfactant (NIS), water conditioner, drift reduction technology (DRT) and deposition agent are allowed or not excluded on the label. When using along with dicamba in dicamba tolerant crops review the website associated with the relevant dicamba containing product for any additional tank mix instructions.

Use rate as a Drift and Volatility Reducing Agent with Dicamba Tank Mixes:

Use AQUADRAFT DICAMBA ALL-IN-ONE at a minimum of 1% v/v or 20 oz/A.

Mixing: To a clean spray tank add sufficient clean water to fill the tank to ¾ full. Be sure to agitate the tank during mixing and application. Add AQUADRAFT DICAMBA ALL-IN-ONE to the spray mixture prior to adding the pesticide(s) and other adjuvants. Finish with remaining water and maintain agitation to mix. Be sure to allow sufficient time for mixing prior to application. When using a tank mix for the first time, prepare a jar test to assess the mixture for compatibility.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a dry place, in original container only with lid tight. Do not store near heat or open flame. Do not store with food, feed or other material to be consumed by humans or animals.

DISPOSAL: Do not contaminate water sources by cleaning of equipment or disposal of wastewater. Do not re-use empty container. Triple rinse container and pour rinse water into the spray tank. Recycle or dispose of containers according to local, state and Federal Laws.

PRECAUTIONARY STATEMENTS

Avoid inhalation, contact with eyes, skin or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or smoking tobacco.
