### GENERAL INFORMATION

AQUADRAFT™ PREMIUM is a blend of water conditioning agent (ammonium sulfate), surfactants, and humectants. AQUADRAFT PREMIUM contains antifoaming agent to minimize foaming.

AQUADRAFT PREMIUM may be used with pesticides that either require or suggest the use of surfactants and/or ammonium sulfate as the recommended adjuvant.

# RATE RECOMMENDATION

AQUADRAFT PREMIUM should be used at 0.75% v/v to 2.5% v/v.

Do not use at rates above 5% v/v.

Additional adjuvants may be added for deposition, retention and canopy penetration. Always read and follow the specific pesticide label directions, adjuvant suggestions, rates and mixing instructions.

## HANDLING INSTRUCTIONS

AQUADRAFT PREMIUM rates may be adjusted for varied herbicides and weather conditions.

Add AQUADRAFT PREMIUM to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

### MIXING INSTRUCTIONS

- 1. Fill tank 1/2 full of water and begin agitation.
- 2. Add the required amount of AQUADRAFT PREMIUM while agitating.
- 3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s)

## STORAGE AND DISPOSAL

Store product in original container. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below 0 degrees F.

Triple rinse (or equivalent) prior to disposal. Add rinsate to spray tank. Offer container for recycling or dispose of properly according to state and local authorities. If burned, stay out of smoke.

## PRECAUTIONARY STATEMENTS

Harmful if swallowed, absorbed through skin or inhaled. Avoid contact with eyes, on skin or clothing. Avoid breathing vapors or spray mist. Remove and wash contaminated clothing before reuse.
