DIRECTIONS FOR USE

GENERAL INFORMATION: CROPFUSE® NIS is a multi-function spray adjuvant for the enhancement of spreading of spray droplets and increased coverage of the intended target. CROPFUSE NIS may be applied with insecticides, fungicides, herbicides, PGR's and nutrients at the label use rates or rates recommended on the pesticide label.

The addition of adjuvants to some pesticides and/or fertilizers may cause phytotoxicity to plant foliage. Prior to using CROPFUSE NIS the applicator should have experience with the pesticide combination, including CROPFUSE NIS, or should conduct a test to determine plant safety.

SHAKE WELL BEFORE USING.

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY. NOT FOR AQUATIC USE.

USE RATES

Use 0.5 - 4 pints of CROPFUSE NIS per 100 gallons of spray solution.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

- Compatibility agent and/or antifoam, if needed
- AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
- Dry soluble and suspension fertilizers / micronutrients
- Liquid drift retardants and flowable formulations (F & FL)

- Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
- Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
- Liquid micronutrients and fertilizers
- Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
- Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. *If product freezes, warm to room temperature and agitate before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. CONTAINER DISPOSAL:* Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. Decontaminated containers and materials must be disposed of in a manner allowed by local, state and federal laws and regulations.
