GENERAL INFORMATION

TRUTRACK® FUNGICIDE PASS adjuvant contains an NPE-free surfactant and is designed to enhance fungicide and insecticide applications and may be used with herbicides and other crop protection products.

TRUTRACK FUNGICIDE PASS helps optimize droplet adhesion, which reduces bounce and increases droplet spreading for improved contact, coverage and canopy penetration. These features lead to enhanced agronomic performance that provide more fungicide and insecticide where it is needed the most.

USE RATES

For use with fungicides and insecticides and may also be used with herbicides and other crop protection products. Prior to use, read all directions on this label.

Ground application: 6-10 oz per acre

Aerial or Drone application: 1% v/v (use 3 oz per acre with 3 gallons of water or less)

Before mixing pesticides with TRUTRACK FUNGICIDE PASS, conduct a jar test to determine compatibility.

MIXING

Add TRUTRACK FUNGICIDE PASS after pesticides or other adjuvants are added but prior to complete filling of the spray tank.

May be used through direct, in-line injection.

Do not mix TRUTRACK FUNGICIDE PASS with other adjuvants in an induction system or container when all the products are undiluted. Once mixed in water, all products are compatible.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage, disposal or cleaning of equipment. **Storage:** Store in original container only and keep sealed, in closed storage areas. Storage above freezing is recommended. If product freezes, warm and agitate (recirculate) prior to use. **Adjuvant Disposal:** Wastes resulting from the use of this product may be disposed of through on-site spray application or at an approved waste disposal facility. **Container Disposal:** Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program. Contact your state and local ACRC recycler or visit the ACRC web page at www.agrecycling.org. Decontaminated containers may also be disposed of in a sanitary landfill.
