Mixing: Dissolve the recommended amount of UPSHIFT C + K into approximately one half the required water. Slowly add the remaining water while maintaining constant agitation. Water quality and temperature will determine maximum solubility. Warmer water temperatures increase solubility and shorten dissolving time. As this product goes into solution, the water temperature will drop. Therefore it is important when preparing concentrated solutions to allow for this temperature drop to insure that the fertilizer is completely dissolved.

GENERAL INFORMATION

UPSHIFT® C + K, powered by ETHER™ Enzyme Technology, is recommended for use on, but not limited to, vegetable and row crops, deciduous fruit and nut trees, citrus, avocados, vine and berry crops, pasture and range grasses and most other crops.

RATE RECOMMENDATIONS

Row Crops: For starter and side-dress applications apply 2 to 5 lbs per acre dissolved in adequate water.

Specialty Crops: Dissolve 5-30 lbs in sufficient water to treat one acre.

DO NOT exceed 1 lb UPSHIFT C + K per gallon of water. Repeat as needed. UPSHIFT C + K must be dissolved in water before mixing with other liquid fertilizers such as UAN, ATS and 10-34-0.

MIXING AND HANDLING INSTRUCTIONS

Compatibility: UPSHIFT C + K may be applied separately or in conjunction with most other fertilizers. A compatibility test is recommended if the desired combination has not been previously used.

DO NOT use this product with ammonium thiosulfate, potassium thiosulfate or other high pH or high free-ammonia products. When mixing with UAN solutions, add one gallon of water for every one gallon of UAN solution and blend well before adding UPSHIFT C + K to insure complete and thorough mixing.
