4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

- Suitable Extinguishing media: Water spray (fog), foam, CO₂, or dry chemicals may be used in areas where this product is stored.
- Specific Hazards: Water spray may be ineffective on fire but can protect fire fighters and cool closed containers. Use fog nozzles if water is used. Do not enter confined fire space without full bunker gear (helmet with face shield, bunker coats, gloves and rubber boots).

6. ACCIDENTAL RELEASE MEASURES
