REVLINE® HOPPER THROTTLE™ SOYBEAN is an 80/20 talc, graphite, nutrient and microbial planter box delivery system for use in soybeans.

#### DIRECTIONS FOR USE & RATE RECOMMENDATION

##### DO NOT ACTIVATE BIO-CAPSULE UNTIL READY TO USE. SHAKE BETWEEN EACH USE.

Read and follow all label directions for use on package. Once ready to plant, remove the safety clips from the BIO-CAPSULES. Push down on the buttons atop the pail to release the biologicals into the base. Seal the pail and shake aggressively to blend the contents. Before each application, aggressively shake contents to ensure the correct volume is applied.

The combined products (1 pail) treat 40 units of soybeans at 140k seeds per unit.

For single-row unit planters, use the enclosed scoop to measure out blended contents. One scoop treats 1 unit (140k seeds) soybeans.

#### STORAGE & DISPOSAL

**Storage:** Keep in a cool, dry place. Keep out of direct sunlight. Do not exceed storage in 77°F and above for an extended period of time. Do not freeze product.
