PRODUCT DESCRIPTION

TRUTRACK® C is a specially formulated deposition aid with drift reducing properties that reduces the number of spray droplet fines less than 150 micro and increases the VMD (Volume Median Diameter) of spray droplets. TRUTRACK C generates a more uniform droplet size spectrum resulting in more enhanced on-target deposition and coverage of spray.

TRUTRACK C is formulated for mixing with liquid AMS and AQUADRAFT® C concentrate.

Can be used with most herbicides, fungicides and insecticides that are labeled for use in agriculture or forestry.

RATE RECOMMENDATIONS

Use 2 - 6 fl. oz/acre or 0.125% - 0.375% v/v.

DIRECTIONS FOR USE

Other adjuvants may be added for deposition, retention and canopy penetration. Always read and follow the specific pesticide label directions, adjuvant suggestions, rates and mixing instructions.

Mixing Instructions:

When mixing with water conditioner and surfactant:

- 1. Always add water conditioning product first
- 2. Follow with surfactant, such as AQUADRAFT C concentrate
- 3 Then add TRUTRACK C

Proper nozzle selection and operation (pressure and spray angle), combined with good operator evaluation and decision making on wind direction, temperature inversions, application speed and susceptible crops in the area are necessary for maximum drift reduction

Always use good operating procedures to minimize drift potential. Actual use rate may be increased or decreased with in the desired rate range to achieve optimum results. Always read and follow label directions.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal. Do not contaminate water by runoff from equipment wash water or spray material. Store in a dry place. Store in original container only with lid tight. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Do not freeze.

Triple rinse (or equivalent) prior to disposal. Add rinsate to spray tank. Offer container for recycling or dispose of properly according to federal, state and local authorities.

Minimum storage temperature: 32º F.
