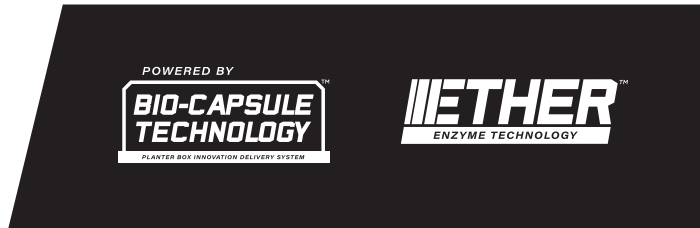

Hopper Throttle® MaxStax™ Corn is a seed fluency, nutrient and microbial planter box delivery system for use in corn. It is formulated to improve plant health and vigor, enhance nutrient utilization in the soil and serve as a food source for microbes.

### DIRECTIONS FOR USE & RATE RECOMMENDATION

**DO NOT ACTIVATE BIO-CAPSULE UNTIL READY TO USE. SHAKE BETWEEN EACH USE.**

Read and follow all label directions for use on package. Once ready to plant, remove the safety clips from the BIO-CAPSULES. Push down on the buttons atop the pail to release the contents into the base. Seal the pail and shake aggressively to blend the contents. Before each application, aggressively shake contents to ensure the correct volume is applied.

The combined products (1 pail) treat 50 units of corn at 80k seeds per unit.

### STORAGE & DISPOSAL

**Storage:** Keep in a cool, dry place. Keep out of direct sunlight. Do not exceed storage in 77°F and above for an extended period of time. Do not freeze product.
